A Note of interest to Australian archivists: ARANZ has presented a submission to the Secretary for Internal Affairs recommending that the 100 year restriction on census records specified in the Statistics Act should be replaced by a closed period of 70 years after each census.

The first issue of the 'Bibliography' Bulletin (printed works, archives, manuscripts) comprises mainly exploratory articles and suggestions about the bibliography's format and content.

THE AUSTRALIAN LIBRARY JOURNAL. Vol. 29, No. 1, February 1980 + . A new (Mark V) look for ALJ: serious, scholarly and quarterly. News and 'happenings' are now reported in *Incite*, a fortnightly newsletter. The first new ALJ includes Denis Richardson on librarianship in the 1980's, Ann Brooke on government information, Peter White on official secrets and government openness in Britain, Joe Hallein on library services in Tonga and Samoa and Isabella Trahn on librarianship in Asia. CONNELL, R.W. and T.H. Irving. Class Structure in Australian History: Documents, Narrative and Argument. Melbourne: Longman Cheshire, 1980. xii + 378 pp. \$A 11.95. An insightful and challenging account of the history of class in Australia. Interesting also for its use of documents as an integral part of the text: 'The documents are means to convey further detail on points that the other sections treat generally, and particularly to convey the lived reality that we hold to be crucial to an understanding of class formation. They are theoretically important, not mere illustrations'. Documents reproduced comprise written, printed and photographic records from archives and libraries throughout Australia.

DANIELS, K. and M. Murnane. Uphill all the way: a documentary history of women in Australia. St. Lucia: University of Queensland

Press, 1980. xii + 335 pp. A selection of documents covering 'a diverse range of women's experiences' from the convict era to the 1950's. The collection is divided into four parts: Outcasts of Society (convicts, industrial schools, destitute women); Private Lives (aboriginal women, prostitution, family and motherhood); Working Women; Women and Politics. Documents reproduced include written, printed, illustrative and tape-recorded material.

HICKERSON, H.T. ed. SPINDEX Users Conference: Proceedings of a Meeting Held at Cornell University, Ithaca, New York, March 31 and April 1, 1978. Ithaca, N.Y.: Department of Manuscripts and University Archives, Cornell University Libraries, 1979. x + 125 pp. A conference of users and intending users of SPINDEX (Selective Permutation Indexing), a system designed to produce a variety of computer-generated bibliographic aids for archival holdings. The fourth conference on SPINDEX to date, this one attracted representatives from 21 institutions; over 40 different applications were discussed.

HUDSON, J.P. Manuscripts Indexing. London: British Library Board, 1979. 43 pp. \$A5.00 (including airmail postage). Available from: J.P. Hudson, Head of Large Collections, Department of Manuscripts, The British Library, Great Russell St., London, England WC1B 3DG. A guide 'to the current practice of the Department of Manuscripts in compiling the printed indices to the Catalogue of Additions to the Manuscripts in the British Museum (Library).' Appendices deal with the arrangement and dating of manuscripts, use of different types, and abbreviations.

LIBRARY AND INFORMATION SERVICE OF WESTERN AUSTRALIA. Annual Report 1978-79. Perth: Library Board of Western Australia, 1979. A sesquicentenary Report, celebrating 150 years of Public Libraries in W.A. Nicely illustrated and informative about information services in W.A., including the archival services provided by the State Reference Library.

LIBRARY ASSOCIATION OF AUSTRALIA. Conference. 20th, Canberra, 1979. Alternative futures. Sydney: Library Association of Australia, 1979. viii + 458 pp. \$A16.70. Papers given at the main sessions of the 20th Biennial L.A.A. Conference. Sections: user needs and social change; information delivery; libraries and information services; the future for librarians. Well worth archival perusal in order to arouse awareness about possible (desirable and undesirable) futures for the archival profession.

Included also: a short history of sound recording, directories of (U.S.) manufacturers and suppliers and of North American sound archives, bibliography.

A comprehensive and informative overview of minicomputer developments in Australian librarianship with much in the way of technological, social and legal implications for archivists to consider.

Canberra: Institute for the Conservation of Cultural Material Inc., 1978. 54 pp. \$A5.00 (surface post free). From: Dr. A. Bos, C/- Australian War Memorial, P.O. Box 345, Canberra City, A.C.T., Australia, 2601. An essential handbook for any agency or individual responsible for the guardianship and custody of cultural and informational resources. Tells what to do in emergency situations but, more importantly, emphasises the need to prepare for natural or human-created disasters.
