ISBN 971 652 4325 (paperback). £19.95 hardback, £9.95 paperback. Covers the holdings of 155 institutions in the Republic of Ireland and Northern Ireland. A directory compiled from questionnaire results with indications of the type and extent of holdings. Does not include business or labour organisations.

Hensen, Steven, compiler, Archives, Personal Papers and Manuscripts. A Cataloguing Manual for Archival Repositories, Historical Societies and Manuscript Libraries. 2nd edition. Chicago, Society of American Archivists, 1989. 196pp. Appendices. Index. Paperback. US\$ 19 SAA members, \$26 non-members. Postage extra. A major revision of the first edition published by the Library of Congress in 1983. Sections on rules have been clarified and re-arranged. New sections on formulating headings for personal, geographic and corporate names. Examples in text all give MARC codes, and there are additional tables relating this manual's descriptive elements to MARC fields. A substantial administrative history is followed by guides to the Chamber Records (legislative) and the Office Records (administrative). Includes lists of Speakers and Clerks of the Assembly, and Premiers of NSW. There are also notes in the correct citation of the records, and appendices contain item lists for selected series. Examines the characteristics of common environmental pollutants and their effects on archival materials. Includes detailed list of the types of synthetic polymers and plastics likely to be found in recent records stored in archives. Suggests simply anti-pollution strategies which can help archivists in the physical defence of the records for which they are responsible. Gives step-by-step instructions for the care of negatives, in various media, especially those which have already begun to deteriorate. Also covers storage of negatives. Rhoads, James, The Role of Archives and Records Management in National Information Systems: A RAMP Study. Revised edition. PARIS, UNESCO, 1989. 72pp. Bibliography. PGI-89/WS/6. The purpose of this RAMP study is to provide general information about the value of archives and records management to decision-makers. It promotes the cultural benefits of the preservation of national archival resources and the economies and efficiencies of well-run management programs. It has been updated because of its value to developing nations. Although directed at decision-makers in national governments, it is also appropriate in other contexts where managers may need reminding about the importance of archives and records management to their organisations. Approx. \$59.40. Includes a section on the history of the arrangements for administering the collections of presidential papers and legislation relating to them. Entries for individual presidents usually include biographical details, general outlines of their papers and lists of series. This book is a user's directory but also a history of the institutions and collections whose role is to preserve the evidence of the public lives of American presidents.
