Australian Archives. Lighthouses in Australia: A Guide to Records held in the Australian Archives. Canberra: Australian Government Publishing Service, 1991. 172 pp. Index. ISBN No. 0642166250. Price \$8.00. The first in a series of subject guides proposed for publication by the Australian Archives. It lists the records by state, with supplementary chapters on records of the central administration, records on lighthouse ships, and photographs. A map detailing the location of all lighthouses covered in the guide is also included. Boles, Frank. Archival appraisal. New York: Neal-Schuman Publishers, Inc. 1991. 118 pp. ISBN No. 1555700640. Bibliography and index. Price \$52.60. Explores the methodologies archivists employ to select records for long term retention. It aims to improve and share the selection methodology with other information professionals. Burns, Eva, editor. EDICAST. Canberra: 1991 (Issue 1). ISSN No. 10369155. Gratis. A bi-monthly journal initiated by the Procurement Policy and Government Services division of the Commonwealth Department of Administrative Services to promote the development

of a network of EDI (Electronic Data Interchange) practitioners across the three tiers of government. Its aims are stated as: 'to build an informal network of those involved in public sector EDI projects concerned with purchasing; and provide a forum for information exchange'. Cerri, Roberto, editor. Archivi and Computer. San Miniato: 1991 (Issue 1). Price £15,000 liré each issue or £50,000 liré annual subscription. The first issue of this journal, which the editor introduces as 'interested overall to the automation in archives', includes some observations by the editor on the Statement of Principles produced by the Ad Hoc Commission on Descriptive Standards of ICA. Emerson, Peter, editor. How to manage your records: a guide to effective practice. Cambridge: Institute of Chartered Secretaries and Administrators. 1989. 190 pp. Price £27.50. Published by ICSA to complement the booklet 'The disposal and retention of documents' it states its main objective is to make managers aware of the problems involved in creating and handling records and information. Its eight chapters lead the reader through the records management cycle including policy formulation, developing a program, establishing retention control, storage, formats, etc, in addition to discussing issues such as the use of consultants and the future of records management. Hevelawa, Jacob, compiler. A guide to the records of the Department of the Administrator: Guide to Groups of Records in the National Archives, No. 2. Port Moresby: National Archives and Public Records Services, 1991. ISBN No. 9980911239. 37 pp. Gratis. The second of a series of guides planned for publication to cover groups of records in the National Archives. The records described in the Guide cover documents created and maintained by the Department of the Administrator. Some information on the functions and activities of the various departmental branches is provided together with details on arrangement and on available complimentary sources. McCarthy, Gavan, compiler and editor. Guide to the Archives of Science in Australia. D. W. Thorpe, 1991. 291 pp. ISBN No. 0909532974. Includes index and appendices. Price \$70.00. Published in association with the Australian Science Archives Project, the guide is not a comprehensive listing of all records of individuals relating to science in Australia, but is intended to lead the reader to other major sources outside the Australian Archives and the State and Territory Government archive institutions. The body of the text comprises entries arranged in alphabetical order by surname of individuals. Appendix I lists individuals by major occupation. Available from D. W. McKernan, Michael. Here is their spirit. A History of the Australian War Memorial 1917-1990. University of Queensland Press, 1991. 388 pp. ISBN No. 0702224138. Bibliography and index. Price \$39.95. This book is a commissioned history of the Australian War Memorial. It provides a unique insight to the people, their work and the politics behind the establishment of the Memorial and its development to date. It contains many interesting photographs from the Memorial's collection and other sources. Based primarily on a survey of nineteen departments, this report gives an insight into how central government agencies go about recording and using information to maintain the Government's collective memory. Published for state agencies, this series of booklets and brochures covers many aspects of records and information management. The 1990 survey has been expanded to cover hardware, software, online information retrieval and new technologies. South Australia State Records, Reference Services Branch. Ancestors in Archives. State Records: 1991. 91 pp. Includes index. Price \$12.00. Introduced as a source of information for family history research, it includes material held by State Records and other organisations and Government agencies. Speirs, Bill. Temora Community Archive, its development and function. Temora: Temora Historical Society Inc. 1991. 29 pp. Attachments. Gratis. This is a project report documenting the establishment of the Temora Community Archive, its background, principles and method of operating. Providing a useful insight into the logistics of establishing and operating a small community archive, it describes how the development of the Temora Rural Museum led to an expansion of activities in the area of the society's paper based records. Wright, Benjamin. The Law of Electronic Commerce; EDI, Fax and Email: Technology, Proof and Liability. Boston. 1991. 464 pp. ISBN No. 0316956325. Includes appendices, glossary and table of cases. Reported to cover the legal issues that surround the validity and retention requirements for material generated by computer and/or transmitted electronically, this book raises legal, ethical and operational questions for records management professionals.
