*Archives and Manuscripts* appears twice yearly, usually in May and November. Editorial deadlines are 15 January and 15 July respectively.

Separate indexes to vols. 1–6 of *Archives and Manuscripts* have been published. *Archives and Manuscripts* is currently indexed in *Australian Public Affairs Information Service*, *Library and Information Science Abstracts* and *Historical Abstracts*.

## **Advertising**

## **Preparation of Manuscripts**

Contributors are requested to submit manuscripts in the following manner.

Articles should be presented on both disk and hard copy (double spaced, on one side of the paper only, leaving an adequate margin for instructions). Please contact the Editor to discuss disk format options.

A short abstract, approximately 100 words, should be included, together with a brief biographical note.

Articles longer than 5 000 words may need to be divided into parts and published in one or more issues.

Illustrations are welcome—good quality black and white prints are best for reproduction.

The *Macquarie Dictionary* and the fifth edition of the Australian Government Publishing Service *Style Manual* are used for spelling and style, including endnotes. Bibliographic details should be given in full, without abbreviations.
